

NOTICE OF ELECTION TO INCREASE MILL LEVY

**Springfield Cemetery District Ballot Issue
6A MILL LEVY INCREASE**

SHALL THE SPRINGFIELD CEMETERY DISTRICT TAXES BE INCREASED BY AN AMOUNT NOT TO EXCEED 90,000.00 ANNUALLY IN THE FIRST FULL YEAR (2018 TAXES PAYABLE IN 2019), AND BY WHATEVER ADDITIONAL AMOUNTS ARE RAISED ANNUALLY THEREAFTER BY A MILL LEVY INCREASE AT A RATE OF 2.00 MILLS OVER AND ABOVE THE EXISTING MILL LEVY RATE OF 1.124 FOR A TOTAL MILL LEVY OF 3.124 MILLS FOR THE PURPOSE OF PAYING THE DISTRICT'S ADMINISTRATION, OPERATION AND MAINTENANCE EXPENSES; AND SHALL THE DISTRICT BE AUTHORIZED TO COLLECT, RETAIN AND SPEND THE PROCEEDS OF SUCH TAXES AND ALL OTHER AMOUNTS RECEIVED ANNUALLY FROM ANY REVENUE SOURCES WHATSOEVER AS A VOTER-APPROVED REVENUE CHANGE WITHOUT REGARD TO ANY SPENDING, REVENUE-RAISING OR OTHER LIMITATION CONTAINED WITHIN ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION, SECTION 29-1-301, C.R.S., OR ANY OTHER LAW?
